

**New Mexico Library Association  
Annual Business Meeting  
March 31, 2005**

The meeting was called to order at 8:08 a.m.

**President's Report:** President Heather Gallegos-Rex opened the meeting with a report that the New Mexico Library Association is thriving. The Board demonstrated commitment and dedication and considered the welfare of the organization in all that they did.

Accomplishments this year include:

- A new Strategic Plan with an outward focus. This plan may be reviewed on the NMLA website.
- Special Interest Groups are thriving.
- Thanks to Linda O'Connell's efforts, NMLA now can take credit card payments and we have a new ISP with broader capabilities.
- Lorie Christian is our new Administrator.
- NMLA was represented well at Legislative Day. Elizabeth Haskett did an excellent job of coordinating this event and Joe Sabatini kept us all informed.

**Secretary's Report:** Julia Clarke, Secretary, presented the minutes of the 2004 Business Meeting, ably prepared by Susan Magee, Secretary, 2002-2004. Joe Sabatini moved that the minutes be accepted as presented. Alison Almquist seconded and the motion passed.

**Treasurer's Report:** Kathy Albrecht, Treasurer, reported that our budget now is over \$100,000. Joe Becker, the incoming Treasurer, was introduced. The Marion Dorroh scholarship currently is subsidized by the Association and the \$25,000 scholarship fund is in certificates of deposit. The organizational goal of setting aside \$3000 each year is being met. All NMLA units are asked to submit budget requests by May 15.

**Vice-President's Report:** Kathy Matter, Vice-President, extended a hand of welcome to our 82<sup>nd</sup> conference. This year's theme is "Libraries Lend a Hand." Conference organizers received unprecedented support from the business community. Our Conference speakers are nationally known and will both inspire and inform conference participants. NMLA partnered with various organizations and the Albuquerque Museum to bring the "Goodnight Moon to Art Dog" exhibit to Albuquerque.
